\*DURATION OF MOU: This MOU shall be operational upon signing and will have an initial

upon and can provide the necessary resources.

\*COMMUNICATION: All notice, demands and other communication under this agreement in

connection herewith shall be written in English language and shall be sent to the last known

address, e-mail, or facts of the concerned party, any notice shall be effective from the date on

which it reaches the other party.
