WHEREAS: the Maharani Lakshmi Ammani College for Women, desires of entrusting contractor the contract for House keepers, the collage deals.

AND WHEREAS Gemini Security & Allied Services Bangalore has agreed to undertake this work i.e. providing Housekeeping services with required labours and 1 Supervisor, on the following terms and conditions.

NOW THIS INDENTURE WITNESSETH AND IT IS agreed by and between the parties hereinto that:-

The contractor is agreeable to carry out the House keeping Services during the period from 31st March 2021 Housekeeping service sat the rate of Rs 91,602.00 + GST per Month and Toilet cleaning charges 12,000.00 + GST per Month, Including ESI and extra Tax applicable as per rules made by the Government.

WHERE AS the Service Provider is doing business of providing housekeeping services viz., Personnel at the college campus as desired by COLLEGE and as may be mutually agreed from time to time between the parties in accordance with the terms and conditions of this agreement in the manner hereinafter appearing.

- 1) The Service Provider is committed to recruit and provide, experienced, physically & mentally fit personnel in accordance with the Company's standard, with basic training, procedures, practices, etc.
- 2) The Service Provider shall uphold the strictest disciplinary standards for all their personnel and any transgressions are dealt with immediately, and to the fullest extent that the law allows.
- 3) The Service Provider shall provide uniforms, issue identity cards bearing the name of the Service Provider to Housekeeping Personnel.
- 4) Whenever any Personnel go on leave, the Agency will arrange for a suitable replacement immediately.
- 5) The Service Provider shall fully guide, supervise and monitor the House keepers deployed in the College locations by its Supervisors.
- 6) The Second party shall be responsible for deposition of payment of contribution made towards, Employees State Insurance and bear all other similar financial and statutory liabilities as and when required, in respect of all such staff wherever applicable.

- 7) That the Personnel deployed by the Service Provider shall be employees of the Service Provider.
- 8) The Service Provider shall not sub-contract this contract without the prior written permission of COLLEGE.
- 9) This contract for service will be for a period up 31-3-2024 likely to be continued for further three year and will automatically end, unless renewed.
- 10) The Second party shall be solely responsible for complying with all statutory requirements and obligations, especially, but not limited, to those relating to employment of labour, service conditions of labour, payment of minimum wages, and Employees State Insurance, etc.
- 11) In case of any dispute arising out of the terms and conditions of the agreement, the matter shall be referred to a mutually agreed upon arbitrator and decision of the arbitrator shall be binding on both the parties.
- 12) During the Contractual Period, SERVICE PROVIDER may increase the Charges for providing the Housekeeping Services by giving one month's prior notice (a) at any time after the Contractual Period, or (b) if and to the extent that SERVICE PROVIDER's costs of providing the Housekeeping Services are increased for any reason whatsoever, including, without limitation, as a result of inflation, increase in minimum wage, or increase in costs due to changes in wage structure or any changes in law etc. after the Start Date.
- 13) The COMPANY shall pay the Service Provider invoices as per the Charges specified in Schedule I, within 5 working days after the date of receipt of the invoice by the COLLEGE. Any objection by the COLLEGE to any such invoice raised by the Service Provider should be made within 5 working days from the date of receipt of the invoice.
- 14) In the event that any of the payments due to SERVICE PROVIDER pursuant to this Contract are overdue (unless the subject of a notified bona fide dispute) beyond 30 days, SERVICE PROVIDER shall be entitled to claim interest on the outstanding amount at the rate of 2% per month as from the date the sum is due until the date payment is received.
- 15) Parties to this agreement shall be at liberty to terminate this contract by giving 60 days notice in writing and in any event, the said contract shall come to an end on the expiry of the term as mutually agreed upon by the parties unless expressly renewed.
- 16) The courts in Bangalore shall have the jurisdiction.
