Memorandum of Understanding (MoU)

Clause 2. The implementation of any of the types of cooperation mentioned in clause I is subject to the availability of resources and financial support at the institutions involved.

Clause 3. This Agreement will be in effect for three years unless either institution terminates it with a minimum of one month's written notice to the other institution.
