WHEREAS

- A. SLK is an IT service provider.
- B. MLACW is an educational institute.
- C. The Parties intend to collaborate for their mutual benefit wherein MLCAW will implement SLK's learning material and other relevant literature in MLACW's educational programs and in exchange SLK will hire MLACW candidates who have completed the educational program under the terms and conditions as agreed herein.

NOW THEREFORE, in consideration of the mutual promises and covenants contained herein, the parties hereto agree as follows:

1. SCOPE OF THE AGREEMENT

- 1.1. MLACW hereby agrees to include 'Testing Concepts' in their educational curriculum, described in detail in Annexure A ("Course") to this AGREEMENT. SLK may provide valuable inputs to MLACW in the preparation and customization of the curriculum.
- 1.2. Once the Course has been introduced in the MLACW curriculum, upon mutual agreement, the Parties may decide to hold workshops to be conducted by SLK relating to the Course and MLACW shall facilitate the same.
- 1.3. Once the examination for the said Course is conducted in line with the MLACW examination procedure, MLACW shall facilitate and extend the necessary support to SLK to conduct campus interview of the students who have completed the said Course. MLACW shall provide first preference to SLK to conduct the campus interview.

- 1.4. The selection of students shall be subject to SLK's hiring policy and the selection criteria of SLK as set forth in Annexure B (Selection Criteria) to this AGREEMENT, which may change from time to time as per the SLK company policy. SLK shall commit to offering to hire a minimum of 20 students during campus hiring.
- 1.5. There are no financial commitments on either Party. Each Party shall be responsible for its expenditure with regard to the implementation of this AGREEMENT. If there is any financial consideration, the same shall be dealt separately.

2. MLACW OBLIGATIONS

- 2.1. MLACW shall obtain necessary approvals, permissions, licenses of whatsoever nature required for offering the Course from the concerned authorities.
- 2.2. MLACW shall educate the students with the Course as per the industry requirements and standards.
- 2.3. MLACW shall extended necessary support to SLK to conduct workshops for the students who have opted for the Course in the college premises of MLACW.
- MLACW shall engage the qualified and specialized lecturers or teaching faculty for the said Course.
- 2.5. MLACW shall duly inform SLK the examination dates and mutually discuss regarding conducting the campus interviews.
- 2.6. MLACW shall ensure to provide the first right to hire the students to SLK and shall not permit or allow the students to attend any interviews from other companies unless the selection result has been announced by SLK.

3. SLK OBLIGATIONS

- SLK shall provide significant inputs to MLACW in developing suitable teaching material.
- 3.2. SLK shall agree to provide any guest lectures and workshops as mutually agreed between the Parties. However, the guest lectures/workshop shall not be more than 1 in a month/quarter as the case may be.
- 3.3. Subject to MLACW fulfilling its obligations regarding the first right to hire the students, SLK hereby agrees to offer to hire a minimum of 20 students, provided such students meet the SLK's section criteria as set forth in Annexure B to this AGREEMENT and complies with SLK's hiring policy.

4. INTELLECTUAL PROPERTY

The parties recognize and agree that nothing contained in this AGREEMENT shall be construed as granting any proprietary rights, by license or otherwise to any invention or any patent, copyright, trademark, or other intellectual property right of a Party to the other Party.

5. CONFIDENTIALITY OBLIGATION

Both Parties shall treat all information pertaining to the Parties, business, discussions, meetings, presentations, as strictly confidential and shall not use, copy, or disclose, or permit any unauthorized person access to, any trade secrets or Intellectual Property rights, belonging to either Party, which may come to their knowledge during the term of this AGREEMENT,

"Force Majeure" is any external unforeseeable and irresistible event, such as acts of god and war, pandemic or epidemic making it absolutely impossible to fulfill an obligation.

Neither Party shall assign their rights and obligations under this AGREEMENT to any other party without the prior written consent of the other Party.
